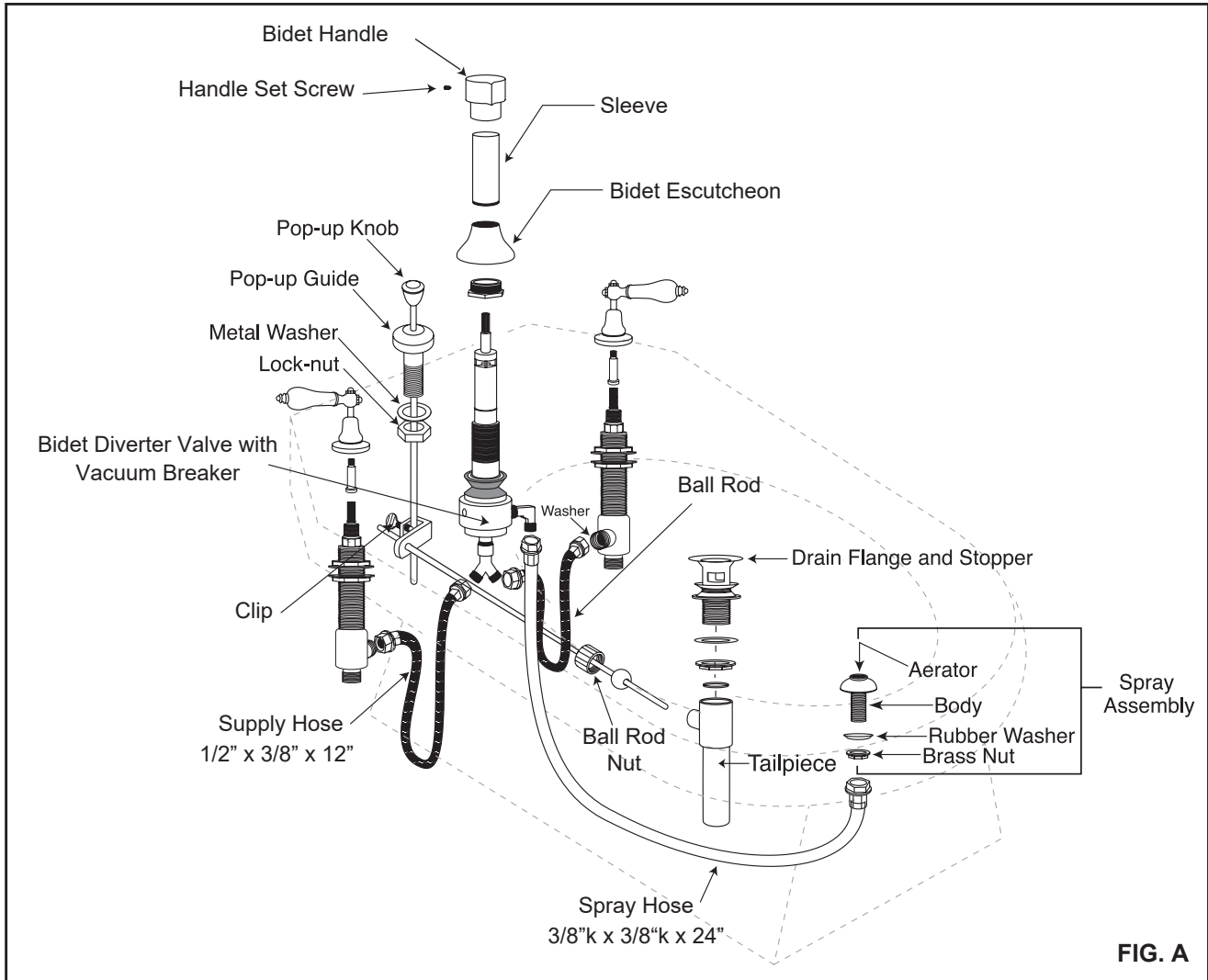


NOTICE: These instructions do not represent step-by-step directions. They are a product supplement only to be used by a qualified/licensed plumber. We recommend all plumbing fixtures be installed by a professional. PLEASE INSPECT PRODUCT PRIOR TO INSTALLING. Carefully review all pre-assembled parts. It will be necessary for the various parts to be reassembled exactly as shown.



Integral Vacuum Breaker/Diverter Installation (FIG A):

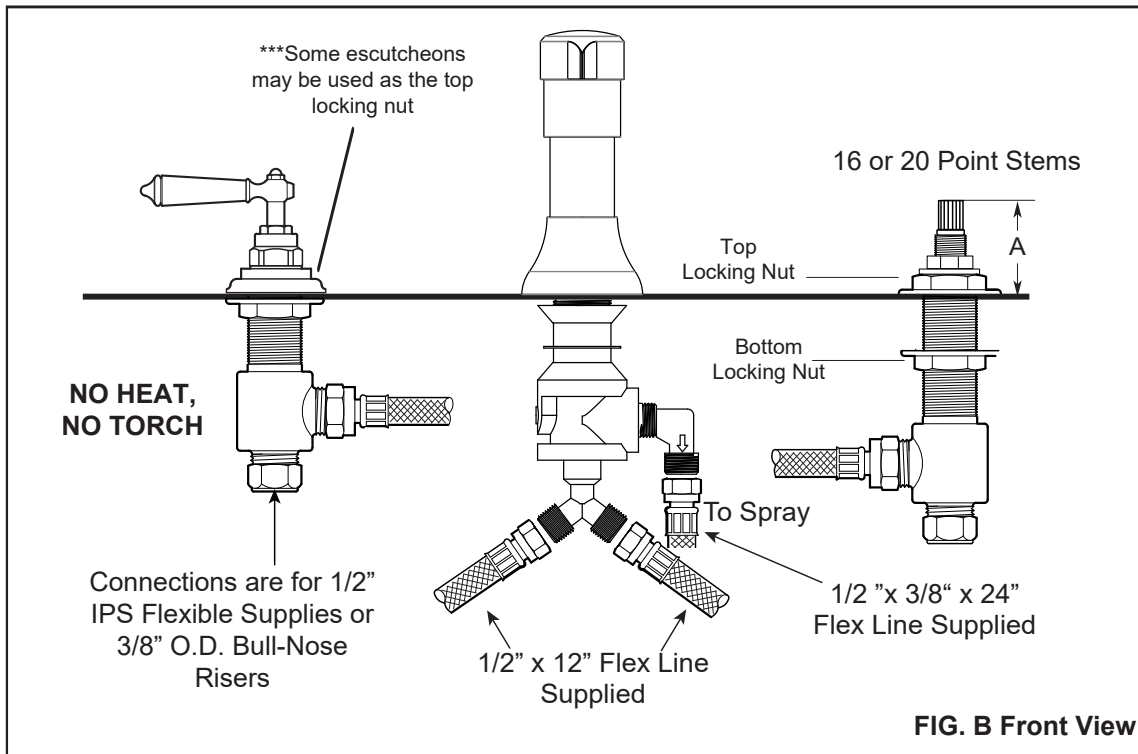
1. Vacuum breaker requires 1-1/4" hole in the surface. Diverter controls water flow between douche spray & flushing rim. Remove the handle, sleeve, and escutcheon from the valve body. Ensure the elbow's arrow is pointing down. Hand-tighten both pieces, as over-tightening may negatively affect the seal's quality.
2. Remove the mounting nut from the valve body and insert the valve body through the bottom of the appropriate hole. Replace the mounting nut and hand-tighten to secure in place. Replace the bidet escutcheon, sleeve, and bidet handle.

CAUTIONS!

Apply teflon tape to threaded areas if applicable. Be sure to check system for leaks, testing valves and lines before closing the deck. Always flush lines of debris. It may be necessary to flush more than once. Do not force handle to close valve- if debris should clog the cartridge, carefully flush (but do not disassemble) cartridge. Use of any lead-based or acidic curing sealant will void the finish warranty. Use only sealants which are neutral curing and not reactive with metal and brass finishes.

Supply Valve Installation (FIG. B):

3. Bidet hot and cold supply valves require 1-1/4" holes in the deck. Handles are shipped pre-assembled to valves; remove the handle pieces and the top locking nut to begin. Some escutcheons may be used as the top locking nut.
4. Install hot and cold valves from underneath the deck using locking nuts and adjust the valve height so that Measurement A is as shown in the chart below. Measurement A differs by handle selection. Valve bodies have stickers to distinguish hot (red) from cold (blue).
5. Test the chosen height by temporarily placing the handle pieces over the valve. After you have checked the fit, remove handle pieces and tighten the locking nuts with a wrench.
6. Remount handle pieces. Handle should open and close in a 1/4 turn.
7. Connect the stainless steel braided hoses from the Y-connector to the outlets of the supply valves. **NOTE:** Carefully hand-tighten hose, as the use of grippers and excessive force will break the seal. After flushing all lines, install the connections from the angle stops to the supply valve inlets (plumber supplies connections).

Douche Spray Installation (FIG A + C):

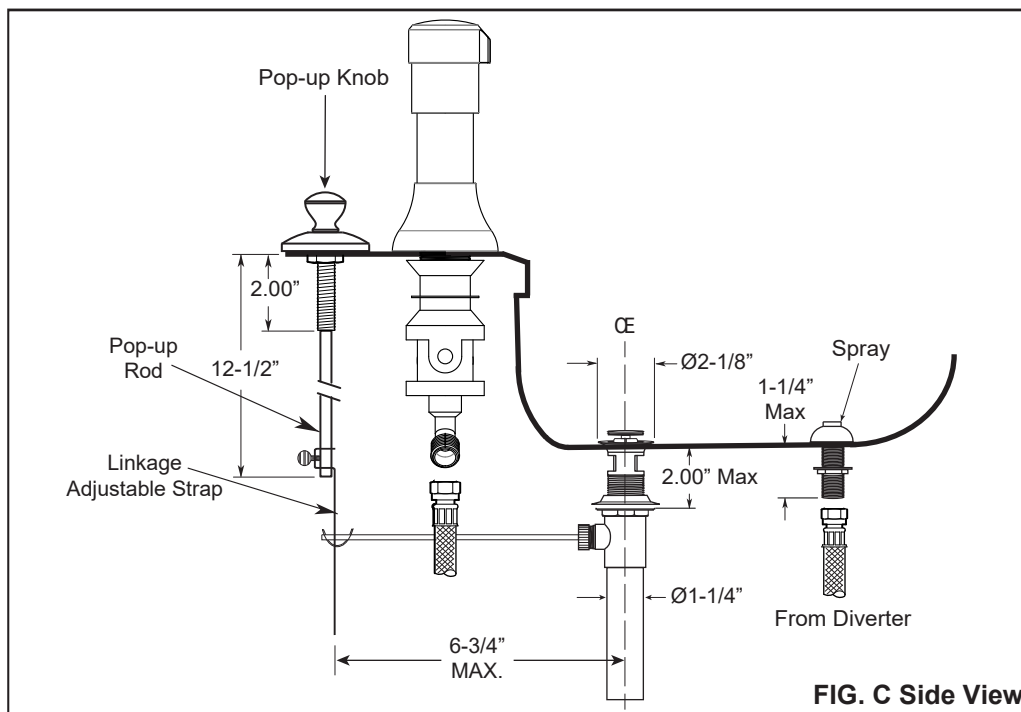
8. Remove the rubber washer and brass nut from the spray assembly. Apply a neutral sealant to the underside of the body where it meets the surface, then insert the body into the appropriate hole from above. Replace the rubber washer and then the brass nut from underneath and tighten to secure in place. The spray hose from the elbow of the diverter can then be connected to the end of the body. Flush lines before continuing.

Pop-up Guide Installation (FIG C):

9. Remove the metal washer and the lock-nut from the body of the pop-up guide. Apply a neutral sealant to the underside of the guide body where it meets the surface, then insert the pup-up guide into the appropriate hole from above. Replace the metal washer and the lock-nut and tighten to secure in place. The pop-up rod and knob can then be dropped through from above to be attached to the linkage strap in the pop-up drain installation.

Pop-up Drain Installation (FIG C):

10. • Remove the flange and stopper and apply neutral sealant to the bottom of the flange. Install drain body through the bottom of the basin hole and attach to the flange. Verify that the hole for the ball rod is facing towards the back of the basin and tighten the mounting nut against the basin.
- Remove the threaded tailpiece, apply teflon tape to seal the threads, and reattach to the drain body.
 - Install the stopper into the flange and swivel so that the hook at the bottom can catch the ball rod. Verify that the ball rod ball is surrounded by the cone washers and that the ball rod nut is facing towards the back of the basin, then install the ball rod into its hole in the drain body and through the hook for the stopper. Tighten the nut so that the rod is secure, but can move freely up and down.
 - Attach the pop-up rod to the linkage adjustable strap and secure with the screw. Use the clip to attach the ball rod to the linkage adjustable strap. Check the action of the stopper and make any necessary adjustments.
 - The waste apparatus can now be connected to the bottom of the tailpiece

What you must do: The faucets must be properly installed according to our instructions and specifications & are for residential use only. The faucets cannot be altered in any way. You must maintain and clean the faucets in accordance with the instructions provided with the product. You must use the faucet(s) for residential use only.

We will then respond and take appropriate action. Do not send us any part(s) of your faucet(s) or its various connecting hoses unless we have contacted you and have sent you an approved RGA form. All transportation charges for returned goods must be paid by the customer.

This warranty super-sedes any other American Faucet & Coatings Corporation warranties, whether oral or written.

This warranty gives you specific legal rights, and you may also have other rights which vary from state to state. LIFETIME WARRANTY ON 1/4 TURN CERAMIC DISC CARTRIDGE

Should the ceramic disc cartridge in your faucet ever fail, American Faucet & Coatings Corporation will replace the failed part free of charge to the original purchaser of the product. Shipping and handling charges will apply. Labor not included. When ordering replacements, denote for widespread or centerset lavatory, Roman Tub, or other. Include age of faucet. (This does not include thermostatic, pressure balance, or diverter cartridges.)

CONSUMER WARNING CALIFORNIA PROPOSTION 65 WARNING

Among other chemicals known to cause harm, this faucet contains lead, a chemical known to the State of California to cause birth defects or other reproductive harm.

All faucets and products made of leaded brass alloys, even those that comply with U.S. Environmental Protection Agency regulations, contribute small amounts of lead to water that is allowed to stand in contact with the brass. This faucet complies with all E.P.A. regulations regarding the amount of lead used in plumbing brass and solder. The amount of lead contributed by any faucet is highest when the faucet is new. The following steps will reduce potential for exposure to lead from faucets and other parts of the plumbing system:

- Always run the water for a few seconds prior to use for drinking or cooking.
- Use only cold water for drinking or cooking.
- If you wish to flush the entire plumbing system of water that has been standing in the pipes or other fittings, run the cold water until the temperature of the water drops, indicating water coming from the outside main.
- If you are concerned about lead in your water, have your water tested.
